Tax-Exempt Organization Discount Requirements

Most non-profit organizations and government entities, generally referred to as tax-exempt organizations, can qualify for a 25% discount on room/event space rental fees.

In order to qualify for this discount, a tax-exempt organization must:

- 1. Be the primary client with control of the event, and
- 2. Be exempt from federal taxes under one of the following IRC Codes, and
- 3. Provide one of the accepted documents for the associated IRC Code at the time of contract signing.

Tax-exempt organizations that fail to provide the accepted documentation or provide accepted documentation after contract signing will not qualify for the discount.
