

# Tax-Exempt Organization Discount Requirements

Most non-profit organizations and government entities, generally referred to as tax-exempt organizations, can qualify for a 25% discount on room/event space rental fees.

In order to qualify for this discount, a tax-exempt organization must:

1. Be the primary client with control of the event, and
2. Be exempt from federal taxes under one of the following IRC Codes, and
3. Provide one of the accepted documents for the associated IRC Code at the time of contract signing.

Tax-exempt organizations that fail to provide the accepted documentation or provide accepted documentation after contract signing will not qualify for the discount.
