About the award:

OSU-Cascades offers scholarships, fellowships and awards from many private and public donors throughout our community. Completing this application enables you to compete for the \$5,250 Bend Park & Recreation District Learn & Earn Scholarship. Any OSU-Cascades degree-seeking student in any major, can apply for this Learn & Earn award. You must be enrolled ¾-time (9+ credits) with at least six OSU-Cascades credits, in good academic standing and hired to work by the BPRD for the Kids Inc. program to be considered for the award. The scholarship requires a commitment of 20 hours per week paid employment in the BPRD Kids Inc. after school program. The schedule is September 6, 2023 (a later start date will apply if you are a mid-year applicant), to June 14, 2024, Monday to Friday 2:00 pm to 5:30 pm with an early start at 12:30 on Wednesdays. Kids Inc. is closed during Bend La Pine School District holidays which usually match OSU-Cascades holidays.

Breaks are as follows:

- Fall: 11/20/23 - 11/24/23
- Winter: 12/18/23 - 01/01/24
- Spring: 3/25/24 - 3/29/24
