- Meeting called to order at 12:03pm
- Moment of positivity
- Meeting minutes for 11/29
 - Jordyn motions to approve minutes
 - Minutes approved 12:10pm
- Student Recreation Discussion
 - Price comparison for memberships at local gyms
 - Juniper - \$49/person/mo or \$147/term
 - Mazama - \$20person//term (COCC)
 - Rock Gym - \$69/person/mo
 - Fusion Fitness - \$24/peron/mo
 - Ice Pavilion - \$55/person/mo
 - Total cost per term for 300 passes - from \$23k to \$72.6k
 - OSU Cascades fitness center
 - Benefits
 - Convenient, all-day access, no additional fee for facility use, student employment/internship opportunities
 - Available 7am-8pm for commuter students, extended times available for residents
 - Available weekends (unstaffed) for residents
 - Possible opportunities

- Fitness classes, 4 classes/week; \$165/term cost for student instructor; \$800/term total cost
- Kinesiology program internship/employment at fitness center
- Faculty and staff required to pay for use
- Fitness center tour
- Budget
 - Level 1 - Facility open 7 hrs/day M-F, no classes offered, \$14,280 total cost (2 terms)
 - Level 2 - Facility open 7hrs/day 7 days/wk, offering 4 classes/wk, \$16,420 total cost (2 terms)
 - Level 3 - Facility open 12hrs/day 7days/wk, offering 4 classes/wk, \$22,420 total cost (2 terms)
 - Optional add ons include additional operation hours/day (\$121), weekend staffing (\$1,694 for staff member at 7 hrs/day and \$2,904 for 12 hrs/day), additional classes (\$165/class), non-student instructed classes (\$100/class)
- Discussion
 - Ginger points out that the space is very small and potentially inefficient for class use
 - Erynn asks how classes and open use can be staggered; Jake suggests scheduling fitness classes at low use times or before opening
 - Jordyn shows preference for level 1 funding as a trial to see if student will utilize the facility; SFC members agree
- Approval of funding
 - Law moves to approve funding of level 1 fitness center option at a cost of \$14,820 for SFC
 - Motion passed at 12:53pm
- Data of facility use by students will be collected and tracked
- Potential opening date of facility is Monday, January 23rd
- Advisor update
- Professional Development update
- Kelly O. Smith's update - health advisor will be hired soon
